

Report to the Parish Community of St. Catherine of Siena

On the 2016 / 2017 Fiscal Year Financial Statements

I am pleased to present the parish's Comparative Financial Statements for the fiscal years 2016 and 2017. These statements are in two parts: The Statement of Financial Position and the Statement of Activities. These are commonly accepted terms used in not-for-profit accounting. For those more familiar with for-profit accounting, these are the Balance Sheet and the Profit and Loss (P&L) Statement respectively.

In review of the Statement of Financial Position, you will note that the Total Assets increased, which is the result of the sale of our previous priest residence and the completed new priest residence located on the same grounds as our beloved church. These transactions were completed without the need to raise additional funds or incur debt. The availability of cash in our accounts remains sufficient and meets the necessary reserve required by the Diocese.

In review of the Statement of Activities, you will see that there is a new income line for Faith to Move Mountains. We are grateful to the parishioners participating in this very important program that creates an endowment for the Diocesan mission and provides additional short term funding for our parish structural repairs.

Our collections for this past year have diminished. We are truly grateful for the offerings that have been received and understand that Diocesan fundraising is an increased commitment to the church above and beyond your regular offertory. We continue to exercise prudent financial decisions and rely tremendously on our many talented volunteers to augment the efforts of our clergy and administrative staff; nevertheless, expenses continue to rise. If your current financial position permits, we respectfully ask you to please consider contributing additional weekly offerings so that we may continue our parish mission.
